## AMO Policy Update – Draft Resolution for Municipal Recognition of September 30<sup>th</sup> as National Day for Truth and Reconciliation, and New Municipal Resource Materials

Recent discoveries of remains and unmarked graves across Western Canada have led to increased calls for all levels of government to immediately address the recommendations in the Truth and Reconciliation Commission's (TRC) Calls to Action.

All Canadians and all orders of government have a role to play in reconciliation. The TRC's 94 Calls to Action are addressed primarily to the federal, provincial, and territorial governments but also to municipal governments, the corporate sector, and the broader Canadian society. They cover a wide range of government responsibilities including child welfare, education, language and culture, health, justice, commemoration, museums and archives, training for public servants, and a few specific initiatives related to reconciliation.

At the August 14<sup>th</sup> Board Meeting, the AMO Board of Directors approved two resource papers to assist municipal councils' efforts to support Truth and Reconciliation.

The first resource paper provides an overview of the <u>Truth and Reconciliation</u> <u>Commission's (TRC's) Calls to Action</u> that municipal governments can address themselves.

The second resource paper provides ideas and options for <u>what municipal leaders</u>, <u>councils can do to better support and engage Indigenous residents and neighbours at</u>

this time.

These AMO resource papers are meant to be organic and to be revised/updated when appropriate and more municipal resource materials are available.

# Municipal Recognition of September 30<sup>th</sup> as National Day for Truth and Reconciliation – Draft Resolution

The AMO Board of Directors encourages members to recognize September 30th as National Day for Truth and Reconciliation (also known as Orange Shirt Day with the adoption of the following resolution:

WHEREAS the Truth and Reconciliation Commission released its final report on June 2, 2015, which included 94 Calls to Action to redress the legacy of residential schools and advance the process of Canadian reconciliation;

AND WHEREAS the recent discoveries of remains and unmarked graves across Canada have led to increased calls for all levels of government to address the recommendations in the TRC's Calls to Action;

AND WHEREAS all Canadians and all orders of government have a role to play in reconciliation;

AND WHEREAS Recommendation #80 of the Truth and Reconciliation Commission called upon the federal government, in collaboration with Aboriginal peoples, to establish, as a statutory holiday, a National Day for Truth and Reconciliation to ensure that public commemoration of the history and legacy of residential schools remains a vital component of the reconciliation process;

AND WHEREAS the Federal Government has announced September 30th, 2021, as the first National Day for Truth and Reconciliation (National Orange Shirt Day) and a statutory holiday;

THEREFORE, BE IT RESOLVED THAT the Council of the [municipality] of [placename] does hereby commit to recognizing September 30th, 2021, as the National Day for Truth and Reconciliation (National Orange Shirt Day) by sharing the stories of residential school survivors, their families, and communities.

## Resources on the Truth and Reconciliation Commission (TRC) Calls to Action

August 23, 2021



Recent discoveries of remains and unmarked graves across Western Canada has led to increased calls for all levels of government to address the recommendations in the Truth and Reconciliation Commission's (TRC's) Calls to Action.

All Canadians and all orders of government have a role to play in reconciliation. The TRC's 94 Calls to Action are addressed primarily to the federal, provincial, and territorial governments but also to municipal governments, the corporate sector, and the broader Canadian society. They cover a wide range of government responsibilities, including child welfare, education, language and culture, health, justice, commemoration, museums and archives, training for public servants, and a number of specific initiatives related to reconciliation.

Through the work of the AMO Indigenous Relations Task Force (IRTF), various approaches for responding to the Calls to Action will come forward. It is important to note that this is only the beginning of our work on responding to the TRC's Calls for Action. AMO will continue to update this resource document as municipalities share their experiences and we can incorporate responses across the province into this work.

## Approaches include the following:

- AMO support for Council and Staff training in intercultural competency, conflict resolution, human rights, and anti-racism.
- AMO encouragement of its members to recognize September 30<sup>th</sup> as National Orange Shirt Day and the flying of the *Every Child Matters* flag for the month of September at municipal offices.
- AMO exploration of the form and scope of formal and informal relationship agreements between municipal governments and First Nations.

AMO's ongoing work with Ontario Federation of Indigenous Friendship Centres (OFIFC) under our 2020 MOU on policy matters of mutual interest supports these recommendations.

## **Background:**

On June 2, 2015, the Truth and Reconciliation Committee released its final report which included 94 Calls to Action to redress the legacy of residential schools and advance the process of Canadian reconciliation.

The Truth and Reconciliation Commission (TRC) of Canada was constituted and created by the Indian Residential Schools Settlement agreement, and the Commission spent six years travelling across the country to hear the stories of survivors and their families.

As summarized in the opening Executive Summary of the Truth and Reconciliation Commission's report,

"Canada's residential school system for Aboriginal children was an education system in name only... These residential schools were created for the purpose of separating Aboriginal children from their families, in order to minimize and weaken family ties and



cultural linkages, and to indoctrinate children into a new culture – the culture of the legally dominant Euro-Christian Canadian society".

In the six years since the Calls to Action were published, there have been only incremental changes and attempts by all levels of government to implement the recommendations.

## Recent Discoveries at Former Residential Schools

In May and June 2021, more than 1500 graves have been uncovered in Kamloops, British Columbia; Brandon, Manitoba; Marieval, Saskatchewan; and Cranbrook, British Columbia. Investigations are planned or underway at multiple other sites, and there are calls across the country to investigate thegrounds of all former residential schools.

There are 18 former residential school locations in Ontario. According to the Truth and Reconciliation Commission, at least 426 children died while attending these schools, and an unknown number of children are still missing. The TRC has identified 12 unmarked burial sites in Ontario but there are likely more.

AMO, in partnership with the <u>Woodland Cultural Centre</u>, presented a special screening of a virtual tour of the Mohawk Institute Residential School on August 18<sup>th</sup> as part of the AMO 2021 Conference program.

## 1. Treaty 20-Greater Peterborough Area

This partnership has taken a regional approach to First Nation-municipal collaboration, bringing two First Nations, two townships, a regional government, and an economic development corporation together.

- All councils and boards have passed resolutions committing to CEDI from 2017-2020.
- Curve Lake and Hiawatha First Nations now sitting as partners on the County of Peterborough's Official Plan Technical Advisory Committee.
- Co-organized an educational event about the 200th anniversary of Treaty 20 that engaged Indigenous youth and Indigenous knowledge keepers.
- Co-presented at the FCM Annual Conference and Trade Show in Quebec City, June 2019.
- Signed Ezhi-Wiijikiwendiyang (Friendship Accord), November 2019.
- The partnership and the Friendship Accord are featured in a <u>video</u> that was filmed by Indigenous Services Canada.
- Had a Wampum Belt created in March 2020 to honour their commitment to their partnership.

## 2. The City of London

- The City of London is developing plans to address TRC recommendations through the London Diversity and Race Relations Committee. This committee provides leadership on matters related to diversity, inclusivity, equity, and the elimination of discrimination in London.
- At a City of London council meeting, a Two Row Wampum Belt was unveiled. The belt is a replica of "the grandfather of all treaties" and was given as a gift from the Chippewas of the Thames First Nation in the presence of the Oneida Nation of the Thames. It is on display in the Mayor's office to serve as a reminder to all of the deep and abiding friendship and of the mutual duty to respect the lasting principles of the pledge made long ago.

## 3. The City of Ottawa

- The City of Ottawa's council established an Aboriginal Working Committee in 2007 composed of representatives from the Ottawa Aboriginal Coalition, the City of Ottawa, United Way Ottawa, the Ottawa Police Service, and the Ottawa-Carleton District School Board – to provide recommendations to council and identify inter-governmental partnerships.
- The City is currently working with local Indigenous partners to review the TRC's recommendations and determine next steps for approval by city council.
- Ottawa's Police Service partners with several community groups including Wabano Centre for Aboriginal Health and the Ottawa Inuit Children's Centre to run a Soccer Mentorship Program, an initiative of the City's Aboriginal Working Committee.



#### 4. The United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP)

- Toronto and Vancouver, among others, have adopted the UNDRIP as part of the cities' commitment to Truth and Reconciliation.
- UNDRIP is an international instrument adopted by the United Nations on September 13, 2007, to enshrine (according to Article 43) the rights that "constitute the minimum standards for the survival, dignity and well-being of the indigenous peoples of the world".
- The UNDRIP protects collective rights that may not be addressed in other human rights charters that emphasize individual rights, and it also safeguards the individual rights of Indigenous people. The Declaration is the product of almost 25 years of deliberation by U.N. member states and Indigenous groups.
- The City of Toronto and Vancouver's councils have endorsed UNDRIP.
- The City of Toronto adopted the UNDRIP as part of the City's year-long proclamation on Truth and Reconciliation 2013-2014.
- The City of Toronto in its 2003 Vision Statement on Access, Equity and Diversity acknowledged the unique status and cultural diversity of the Aboriginal communities and their right to self-determination. This aligns with Article 3 of the UNDRIP which calls for Indigenous peoples' right to self-determination. Article 11 of theUNDRIP states that Indigenous peoples have the right to practice and revitalize their cultural traditions and customs. In the work of Heritage Preservation and other City divisions that complete environmental assessments, the City of Toronto acknowledges this right by consulting with Aboriginal peoples.

#### 5. Records and Archives

• Toronto has asked the Equity, Diversity and Human Rights Division of the City Manager's Office, in consultation with the City Clerk, to identify records held at the city's Archives and City Divisions that are related to the history and legacy of the residential school system and that could be forwarded to the National Centre for Truth and Reconciliation.

#### 6. Sioux Lookout

- Sioux Lookout formed a Mayor's Committee on the Truth and Reconciliation Committee and has reported a significant number of activities in their report on the action of the Mayor's Committee.
- Activities include attending meetings of the Chiefs of Ontario, Assembly of First Nations, and NAN Chiefs; advocacy for alternative justice and a community justice centre; relationship building through a Friendship Accord; First Nations Community Economic Development Hub; Urban Indigenous Action Plan; Municipal-First Nations Working Groups; and the creation of a Police Services Board with an Indigenous Chairperson, among many others.
- A report from the Committee in 2017 made recommendations on a number of Calls to Action, including Education (Recommendation #8, #11); Health (#23); Justice (#31, #41); Royal Proclamation and Covenant (#47); Public Servants (#57); Missing Children and Burial Information (#75); National Centre for Truth and Reconciliation (#77); Sports (#87, #88).



# What Municipal Leaders Can Do To Better Support Indigenous Residents And Neighbours At This Time

August 23, 2021



A question we have been hearing from members is how can municipal governments leaders and staff be more supportive and be part of the healing, learning, and restoration needed to support reconciliation with Indigenous friends, neighbours, and communities. Municipal leaders are being looked to in order to set the tone and be part of the constructive societal change that is needed and expected.

To set the context, municipal governments are not [part of] the Crown under the Canadian Constitution, the Federal and Provincial governments are. As such, municipal governments are not able to address outstanding rights and claim issues, but we are able to be better neighbours and partners with Indigenous friends and communities.

- 1. Start by listening. Actively listen to the many Indigenous leaders, elders, and speakers who are sharing their perspectives, advice, and wisdom at this time. Listen locally if you can to Indigenous neighbours and at Friendship Centres. Although there are common elements, each survivor and each community has a unique story to share. Learn from what is shared voluntarily but don't ask Indigenous colleagues or friends to educate you.
- 2. Educate yourself about residential schools through the many stories of survivors. May wish to virtually visit the <u>Woodland Cultural Centre</u> which was formerly the Mohawk Institute Indian Residential School, one of the few remaining residential schools in Canada. Be compassionate and self-reflective as survivors and their communities grieve with the recent discoveries of several unmarked children's' burials with likely more discoveries to come.

Educate yourself on the broader area of Indigenous history and perspectives including Indigenous rights under the Canadian <u>Constitution Act, 1982</u> and <u>treaties</u> as a start. More informational links can be found at the end of this document.

- **3. Speak up thoughtfully.** Consider what your and your council's informed contribution will be to the public discussion in support of Indigenous peoples. Although there is a growing frustration with both silence and platitudes, a sincere and heartfelt statement may take some time to develop which should be accompanied with a follow through implementation strategy. Be particularly careful about the use of social media as it is often not the best forum for thoughtful discussion.
- **4. Call for action.** As stated above, municipal governments can't solve issues related to rights and claims. However, they can add their strong voices in support of a call for action to the federal government.

In particular, they can support the Truth and Reconciliation Commission's (TRC) calls to action on residential schools, including the need to fund this essential work. The TRC's recommendations 71-76 ask the federal government to accurately detail the number of children who died, establish a National Residential School Student Death Register, and to locate the bodies of children who died so that they can be respectfully memorialized.

As well, there needs to be a requirement that there is an immediate release all of documents and records related to residential schools in Canada including the names of all missing children – be they federal, provincial and/or church records.

5. Create a Declaration of Mutual Commitment and Friendship with the local Friendship Centre. During AMO's 2020 Virtual Conference, the <u>Declaration of Mutual Commitment and Friendship</u> was signed by the Ontario Federation of Indigenous Friendship Centres and AMO.

Developed and led by the Ontario Federation of Indigenous Friendship Centres (OFIFC) (link <u>https://ofifc.org/</u>) and AMO's memberships, the Declaration highlights the relationships and work being done to improve the quality of life of Indigenous people across Ontario's municipalities. The Declaration emphasizes the leadership of collaborating Friendship Centres and municipal governments and raises the bar for increased future dialogue and partnership. The agreement is designed to help municipal governments and Friendship Centres build relationships in order to improve supports and services for Indigenous people in their communities.

Throughout Ontario, 85 per cent of Indigenous people live in urban and rural municipalities. The OFIFC represents the collective interests of 29 Friendship Centres in cities and towns across the province – places for community members and Indigenous people living in urban spaces to gather, connect with one another, and receive culturally-based services. The centres support and encourage equal access to, and participation in, Canadian society while respecting Indigenous cultural distinctiveness, and have existed in Ontario communities for more than half a century (<u>Declaration of Mutual Commitment and Friendship</u>).

6. Create urban Indigenous-municipal advisory committee (if one doesn't already exist) where there is no Friendship Centre in the municipality. This advisory committee could work collaboratively with municipal service providers and staff with respect to municipal services and programs related to the social determinants of health (e.g., housing, child care, senior services, public health) to make sure that they are being planned, delivered, resourced, and evaluated in a way that serves the urban Indigenous community appropriately and in partnership.

This may also be, or evolve into, a forum for Indigenous and municipal service providers to work together in human and social services areas where program integration and cooperation would benefit all peoples receiving such services in the municipality.

**7. Create or renew Relationship Agreements** between a municipal government and neighbouring First Nation(s) and/or indigenous communities. Many municipal governments have formal or informal inter-government agreements with neighbouring First Nation(s) and/or Indigenous communities covering how they will work together on areas of mutual interest such as economic recovery, tourism, land use planning, and environmental issues. These are different from service agreements on items such as fire protection services, animal services, solid waste, or water/sewer provision. They are the agreements that provide a framework for how all parties will work together on local issues and how dispute resolution can occur if needed.

AMO staff is looking into developing a template framework that includes the key elements in relationship agreements later in 2021 so that it can be available to assist members, First Nations, and Indigenous communities in local discussions about their own Relationship Agreements.



- 8. Support Indigenous colleagues and staff. It is not a usual time. Know that Indigenous colleagues and staff may need time for themselves, their families, and their communities. If possible, employers should try to make sure that employees have access to culturally appropriate employee support programs or counselling.
- **9.** Attend memorial events or ceremonies where non-Indigenous people are invited. Wear orange to demonstrate support for survivors and their families. The *National* Day for Truth and Reconciliation, also known as Orange Shirt Day, on September 30<sup>th</sup> is now a federal statutory *holiday*.

Municipal governments are encouraged to fly the "Every Child Matters" orange flag for the month of September leading up to the *National* Day for Truth and Reconciliation.

#### Purpose

The Planning Division has received an application from Falcon Home Construction Inc. to remove Part Lot Control from Lot 6 of Registered Plan 52M-33. This has been confirmed by a letter from the applicant's Barrister & Solicitor, Stephanie Lalonde. (See attachment).

It is not normal practise to show individual townhouse or semi-detached lots in a Registered Plan of Subdivision, rather, such lots are usually shown as full lots of blocks of land. A Reference Plan is then deposited to indicate the intended divisions of the lands to facilitate separate legal description and sale.

#### Recommendation

That Council approve the following:

a. That Part Lot Control be removed from Lot 6 of Registered Plan 52M-33 – Eastridge Subdivision; and

b. That Part Lot Control be reinstated on the semi-detached lots in the Eastridge Subdivision, once the subject lots have been created by the appropriate procedure.



What is Part Lot Control?

Once a Plan of Subdivision has been approved under Section 50 of The Planning Act and registered, a landowner may sell any complete lot on that Registered Plan even though he may own abutting lots. However, a landowner may not sell a part of piece of his lot or block on a Registered Plan without further consent under Section 50(5) of The Planning Act. This is referred to as Part Lot Control and has the effect of preventing any division of land in a Registered Plan, other than that allowed for in the approval Plan of Subdivision without approval of the Committee of Adjustment.

The Effect of Removing Part Lot Control

The exception to the above is that Section 50(7) of The Planning Act enables a municipality to pass a bylaw to remove Part Lot Control from all or part of a Registered Plan of Subdivision. Such a bylaw has the effect of allowing the conveyance of a portion of a lot without requiring the severance approval of the Committee of Adjustment.

It is important to note that it has been the traditional practise of developers to use the consent process, as opposed to the removal of Part Lot Control process in further subdividing semis and townhouses, once the structures are built. However, the surveying to create individual parts for each semi-detached dwelling is essentially the same whether a landowner proceeds with a technical severance or with a Part Lot Control Exemption By-law. It becomes the Surveyor's responsibility to ensure that the dividing line between both dwellings is correctly placed along the centre line of the demising wall between dwelling units. The overriding advantage of the Part Lot Control exemption bylaw is the efficiency it brings to the process. The reason it was created is the overall realization to simplify processes once and only once all the Planning issues have been dealt with. Such is the case with this Subdivision, where the public was notified twice through the Zoning and Subdivision processes. The municipality has exercised its' responsibilities in arriving at a Subdivision Agreement to ensure that all adjacent interests have been addressed. Furthermore, any conditions of development are already imposed as part of the Subdivision Agreement. Therefore, the Part Lot Control Exemption By-law is more efficient, not only from the builder's point of view but, more importantly, from the municipality's point of view.



#### Purpose

To purchase one (1) specialized low floor bus for which Cornwall currently has funding approved by Investing in Canada Infrastructure Program (ICIP) through the Metrolinx Transit Procurement Initiative agreements.

#### Recommendation

That Council approve the purchase of one (1) specialized bus from Creative Carriage through the Metrolinx Transit Procurement Initiative process.

#### **Financial Implications**

The one (1) Handi-Transit bus will be included in the 2022 Capital Budget submission.

For 2022, the Corporation has included \$230,000 for one (1) Handi-Transit bus in the Transit ten-year capital forecasted budget (City share \$61,341).



The cost of the bus is \$229,530 excluding HST (net cost to the Corporation-\$233,569.73) and will be funded through ICIP, as follows:

The City of Cornwall portion will be financed, with borrowing costs (principal and interest) funded by the tax base.

To receive the specialized bus in the summer of 2022, the purchase order must be initiated on Tuesday, September 14, 2021.

#### **Strategic Priority Implications**

This purchase supports the Corporation's Mission Statement by enabling a financially and environmentally sustainable bus service while complementing four of the Corporation's 2019-2021 Priorities: provides transportation services for Skilled Labour Force, allows citizens flexible Housing Opportunities, promotes Economic Development, and is a tool in Environmental Sustainability.

#### **Background / Discussion**

The Transit Department would like to enter into an agreement with Creative Carriage to secure one (1) spot on the production line, thus ensuring that Cornwall will receive the bus in 2022. Typically, there is a 9-month lead time for specialized buses.

Metrolinx is a Crown corporation charged with administering Ontario urban transit projects. The Transit Procurement Initiative (TPI) is a Metrolinx program that helps small and medium-sized Ontario municipalities save money by reducing unit costs through higher volume purchases and performance-based specification, avoiding duplicate procurement costs while improving product quality.



The multi-year governance agreement entered by the Corporation is authorized by City of Cornwall By-Law 2019-073 and covers the period of 2019-2024.

The low floor specialized bus is used mostly to transport persons with disabilities door to door but can be used on less busy conventional and community bus routes.

The bus will replace one (1) 2011 low floor specialized bus that will be decommissioned and placed for auction on GovDeals, an online auction platform. The 2011 bus has reached the end of its service life. The standard service life in the industry is 8 years. The modest revenue expected from the sale of the decommissioned bus will be returned to the City's Provincial Gas Tax Reserve Fund as per the agreement stipulation.

Technology is emerging for a hybrid-electric model but is not an option at this time.

With the addition of one (1) new 2022 Creative Carriage specialized bus, the average Handi-Transit fleet age in 2022 will be reduced from 4.9 years to 4.4 years.

#### Accessibility Impact

The Creative Carriage bus is fully accessible for persons with disabilities and have four (4) wheelchair positions incorporated in the seating plan and can seat 15 ambulatory passengers. Cornwall Transit's fleet remains at 100% accessible.

#### **Strategic Priority Implications**

#### **Financial Implications**

The Corporation applied for funding through the Municipal Modernization Program Intake 2 – Third Party Review Stream. The application was successful This project will be funded 100%.

#### **Background / Discussion**

#### Project Overview

RFP 21-P11 invites prospective Proponents to submit qualified independent consultants to provide engineering services to develop and implement a longterm approach to city-wide radio communications. The scope of work to be completed by the Consultant includes identifying the needs of stakeholders within the Corporation of the City of Cornwall who operate radio communications, review industry standards requirements for each department, preparation of specifications and project administration for the implementation of the radio communication system. The consultant must not have affiliations to any commercial communication system vendors; manufacturers; or to any maintenance and services companies.

#### Background

The Corporation has been operating with separate radio systems, which for the most part is no longer serviced or is out of date, and beyond the ability to be maintained by industry service providers.

In 2017, Cornwall Police Service obtained a new dispatch system which identified deficiencies and non-compatibility with other city agencies, such as Fire Services and Municipal Works.

The purpose of this project is to identify the communication need of organizations and department within the City of Cornwall, who operate radio communications in an effort to look at a long-term approach to city-wide communications.

The Cornwall Police Services provide dispatch services to the various fire departments of the United Counties of Stormont, Dundas and Glengarry (SD&G Counties). In order to continue to provide dispatch services to the SD&G Fire Departments interoperability capabilities will be required to be reviewed to determine current and future interoperability expectations.

#### Appendix A – Terms of Reference

The Corporation of the City of Cornwall along with Cornwall Police Services, Cornwall Fire Services and the Departments of Infrastructure and Municipal Works, Transit Services, and Planning, Development and Recreation is soliciting proposal from qualified consultants for engineering services to develop and implement a long-term approach to city-wide radio communications including the replacement and upgrades to the radio communication systems.

The Corporation has been operating with separate radio systems, which for the most part is no longer serviced or is out of date, and beyond the ability to be maintained by industry service providers.

In 2017, Cornwall Police Service obtained a new dispatch system which identified deficiencies and non-compatibility with other city agencies, such as Fire Services and Municipal Works.

The purpose of this project is to identify the communication need of organizations and department within the City of Cornwall, who operate radio communications in an effort to look at a long-term approach to city-wide communications.

The City of Cornwall is a single-tier municipality located in Eastern Ontario and serves a population of 46,589 residents (2016 Census). The Cornwall Police Services provide dispatch services to the various fire departments of the United Counties of Stormont, Dundas and Glengarry (SD&G Counties). In order to continue to provide dispatch services to the SD&G Fire Departments interoperability capabilities will be required to be reviewed to determine current and future interoperability expectations.

#### Scope of Work

#### Phase I – Project Scoping and RFP development

The successful proponent shall complete the following tasks:

- Meet with stakeholders to document their needs and expectations to gain a complete understanding of the desired functionality for the new system;
- Inspect all physical locations such as tower sites and local emergency service providers as needed to understand elements of the current system and inventory equipment;
- Facilitate discussions and guide decision making process among stakeholders to build consensus about requirements and optional system elements to maximize stakeholder buy-in;
- Conduct propagation studies to understand coverage requirements;
- Prepare a report that prioritizes each of the departmental needs including the recommended radio communication systems that ensures minimum industry standards are met for each department. Included in the report must be detailed cost estimation for each department to replace the infrastructure and estimated yearly support and maintenance costs. The report should describe the present life expectancy of the equipment and provide an inventory of any warranties or maintenance agreements still in effect;
- Review and recommend frequency requirements, and ensure that all frequency licensing have been secured for the project;
- Interview SD&G Counites stakeholders regarding their current radio systems and any future upgrades to determine inoperability;
- Prepare the RFP specifications for a managed service using City of Cornwall tender format;
- Provide support to City of Cornwall staff during the RFP period;

• Prepare and answer all RFP requests for clarification. Prepare, with Purchasing, clarifications and addendums using the City of Cornwall format.

#### Phase II– Implementation and Project Management

- Implementation will begin with the Cornwall Police Services and Fire Services followed by the other Departments of Infrastructure and Municipal Works, Transit Services, and Planning, Development and Recreation when applicable considering;
- Provide contract administrative services during the implementation of the communications system;
- Ensure milestones of the project are captured, adhered to and any delays reported;
- Establish appropriate radio coverage guarantee, consistent with propagation study, for signal strength and quality for entire city. This includes service area and in-building coverages;
- Conduct testing of the installed radio equipment with provider for each of the stakeholders;
- Provide all test results and reports to the City;
- Prepare deficiency reports and ensure deficiencies are rectified by the contractor in a timely manner;
- Itemize any out of Statement of Work (SOW) to be addressed with the contractor;
- Review warranties and maintenance agreements;
- Confirm interoperability limitations.

Successful proponent is excluded from bidding on the new system and is prohibited from colluding with any potential radio system contractors.

#### Purpose

To provide Council with an update on the activities of the Economic Development Department for the previous six months.

#### Recommendation

That Council receive Report 2021-149-Planning, Development and Recreation.

#### **Strategic Priority Implications**

Economic development activities support the City of Cornwall Strategic Plan and help to establish Cornwall as the progressive sustainable choice along the St. Lawrence River in Eastern Ontario.

The activities outlined in this report follow recommendations in the Cornwall Economic Development Strategic Plan, which was adopted in 2016.

#### **Background / Discussion**


Cornwall's economy continues to rebound from the effects of the pandemic, however a number of public health measures continue to impact consumers and businesses alike. On July 16, the Province moved into Step Three of the Roadmap to Reopen, which relaxed many of the restrictions that were in place to



counteract the effects of COVID-19. Most recently, Ontario announced that proof of vaccination would be required in select settings starting September 22.

Cornwall Economic Development staff continue to support local businesses in adapting to an everchanging business environment. This includes City staff from a variety of other departments, regional EDOs, provincial and federal officials as well as local community organizations.

The ChooseCornwall.ca website has become an important information hub with a variety of articles and downloadable resources. Activity on the website increased significantly during the pandemic, and remains high, with the website delivering over 130,000 page views during the months of June, July and August: an increase of 64% compared to the same time period in 2019. From January to August, the website delivered 346,000 page views.



Regular email newsletters deliver timely business news to a growing list of over 7500 community and business leaders.

#### **Major Development and Employers**

For the most part, Cornwall's largest employers have continued operations with minimal disruptions. Many if not most, continue to hire to expand their workforce.



Leclerc and Olymel held separate job fairs in August, looking to hire over 100 additional people.

Cornwall's largest employer, Walmart Logistics, continues to recruit for multiple positions and is making ongoing physical improvements to its facilities.

SigmaPoint, Lallemand, Ridgewood, Morbern and other employers are also maintaining high production levels and are very active in recruiting.

Work is just about complete on the major expansion of the Loblaw / Shoppers Drug Mart Distribution Centre on Optimum Drive. Operators of the facility continue to recruit.

Laframboise Group continues to expand and add capacity at its manufacturing complex on Vincent Massey Drive.

CMP Advanced Mechanical Solutions is establishing a 40,000 sf mechanical assembly operation in Cornwall. This is in addition to a 90,000 sf distribution facility it has operated since last year.

Saniton Plastic has established a plastic bottle manufacturing plant and is also producing its own TrueNorth brand of hand sanitizers.

OPG continues to invest in rehabilitation and revitalization projects at the R.H. Saunders Generating Station, although the Visitor Centre is expected to remain closed for the foreseeable future.

St. Lawrence College has welcomed back over 1100 full time students to the Cornwall Campus, under strict public health and safety guidelines. International students account for approximately 15% of the student population.

#### **Commercial, Retail and Office**

Despite ongoing economic disruptions, there is some positive activity in the commercial and retail sectors.

The Eastern Ontario Training Board has opened its new offices on Second Street in Downtown Cornwall. The 5,000 sf campus-style office is also home to the Newcomer Employment Welcome Services Centre, the Cornwall Chamber of Commerce and CÉSOC Settlement Program for Francophones.

The New Pitt Poutinerie restaurant has opened at the corner of Pitt and Third, and Aurra Coffee has opened a coffee and taco stand on Brookdale.



SleepCountry and the LCBO opened earlier this year, and SmartCentres will be celebrating the opening of Winners and Mr. Puff's in the near future.

Work is proceeding at the Iberville commercial plaza in the East End, and two new restaurants - Osmow's and Popeye's - are expected to open in the Fall.

Cornwall Square is welcoming The Beauty Academy, which will operate a hair styling and beauty training centre on the main level of the mall.

I Sabourin Law Office has opened in Le Village, Mike's Printing and Apparel has opened in Downtown, and Bicycle World relocated their store to Ninth Street.

Western Canadian fuel retailer Centex has continued their foray into Ontario with the opening of a new gas station and convenience store on Brookdale Avenue.

Work is progressing on the Hampton Inn development on Vincent Massey. Once completed the new hotel will feature 80 rooms.



Local demand for retail cannabis products continues to attract retailers. Groove Cannabis has opened its doors at Eastcourt, while work is progressing on the High Ties store in Le Village and the Tokyo Smoke store at the Choice Properties Plaza at Ninth and Pitt.

The Cornwall Farmer's Market had a successful season and the central location proved popular with vendors and consumers.



A significant amount of commercial and office space in Cornwall remains vacant, especially on the office side with a number of large office complexes largely inactive. Demand for large scale office space is not expected to improve over the short-to-mid term.

Demand for retail space is also expected to be weak over the next two quarters, with the exception of quick service restaurants and small speciality retail.

The retail mix in many communities, including Cornwall, will be challenged as national retailers shrink their physical store network. A growing number of businesses and government offices are also reconsidering their physical footprint and are offering their employees the chance to work remotely. Consumers have also increased their use of online shopping platforms which are dominated by large international retailers such as Amazon.

All of these factors could have a negative impact on the sustainability of small local main street restaurants and retailers.

The Cornwall Chamber of Commerce has received \$110,000 in funding from FedDev Ontario to develop a shop local campaign. This is in addition to other

programs available including the *Digital Main Street* program and the new *My Main Street* initiative.

In May the *Cornwall Living* magazine returned to profile many new businesses. It was followed by a new *Perch* magazine as well.



#### Residential Development

There are a number of major new residential projects underway in the city. In addition to ongoing development of existing subdivisions, the following are some of the more recent major projects:

- Southbridge Care Homes (160 long term beds) ongoing construction
- Revera (128 long term beds) construction to begin soon
- Heritage Heights Retirement Home (80 units) construction has begun



- Bell Tower (56 units) ongoing construction
- Sunset Court (44 units) nearing completion
- Prime Square (44 units) construction to begin this fall
- Cornwall & Area Housing Corp. (77 units) construction to begin soon
- Saunders Drive subdivision a number of homes are under construction

#### Sector Specific Marketing Efforts

The Department markets to decision makers in key sectors that align with the community's strengths. These efforts include sector-specific efforts in logistics, food processing, and advanced manufacturing along with commercial real estate.

Industrial vacancy rates in Cornwall continue to be very low, with available built space being very hard to find. In contrast, as noted above, there is a large amount of surplus office and retail space.

Over 3200 people have signed up for push notifications for new articles from ChooseCornwall.ca, an increase of 25% over the past 6 months.

Most trade shows and other in-person marketing events have been cancelled for 2021. The Department will participate in the National Job Fair later this fall, and will host a networking reception for the Ontario East Municipal Conference in October (the rest of the conference will be virtual).

The Department continues to work in partnership with regional, provincial, and federal officials to facilitate trade and attract foreign investment.

One key focus includes various marketing initiatives with the Ontario East Economic Development Commission. Cornwall is part of the Regional Marketing Committee and is chair of the Logistics effort which has led to a number of qualified investment leads. Ontario East has launched a new website with an interactive industrial real estate feature.

The Department has continued its partnership with the Ottawa Business Journal to promote local investment opportunities to business leaders in Ottawa and Eastern Ontario.

The partnership has led to a number of articles on Cornwall, with local companies being profiled to their sizeable readership.

In part due to the above marketing efforts, interest in Cornwall, in particular the Cornwall Business Park has been extremely strong with qualified interest from several companies. There are currently approximately 140 serviced acres




available for sale, with an additional 260 acres available upon completion of the extension of Nick Kaneb Drive.

#### **Resident Attraction**

Work continues to attract new residents to Cornwall. Efforts are targeted at young families and individuals that will augment the local workforce and meet the needs of local employers. The Economic Development Department works closely with groups involved with assisting newcomers to settle in Canada.

Cornwall has been profiled in a number of publications in Ottawa, Montreal and Toronto. Advertisements have highlighted the high quality of life in the region, the urban amenities found in the city and the relatively affordable housing.

Local magazines *Cornwall Living* and *Perch*, along with other brochures and guides, form part of the Choose Cornwall welcome kit for new residents.



As major employers continue to report problems in recruiting new people, residential attraction efforts will continue. The availability of housing is expected to remain relatively scarce over the short term and is a mitigating factor.

The Department assists local companies in their recruitment efforts by posting job opportunities on the ChooseCornwall.ca job board. This section of the site remains extremely popular, and more and more companies are finding it very helpful in attracting quality candidates.

#### Tourism

In conjunction with Ontario's reopening framework, Tourism staff were busy planning and carrying out destination marketing efforts during the second and third quarters of the year with a primary focus on local and regional travel.

The tourism sector continues to be one of the most heavily impacted sectors from the pandemic, with a number of tourism-related businesses



(accommodations, attractions, live entertainment venues and others) having yet to fully resume regular operations. Workforce shortages are also a critical issue facing many tourism and hospitality businesses.


Despite these challenges, there are some positive signs for the local tourism sector with both local accommodations and businesses and Cornwall Tourism seeing a return of leisure travelers during the peak summer months.

#### Marketing

In May, Cornwall Tourism published a new *Explore Cornwall Visitor Guide*, a bilingual publication highlighting attractions, amenities and experiences in the city and area. A total of 50,000 copies have been distributed (a second printing run is being considered). The guide is also available digitally on the Cornwall Tourism website.

In an effort to encourage staycations and patronage at local businesses, Cornwall Tourism once again partnered with local MP Eric Duncan and SDG Tourism to mail copies of the Cornwall and SDG Visitor Guides to every household in the riding.

Advertising campaigns for 2021 are focused on a



number of key areas including cycling, outdoor adventure and leisure travel. This includes profiles in select specialty publications, sponsored content in select newspapers as well as digital efforts. A series of FAM (familiarization) tours and social media influencer campaigns have also been developed in partnership with Regional Tourism Organization 9 (RTO 9) to highlight unique food and drink, outdoor adventure and accommodation experiences in Cornwall.

The above efforts have been complemented by ongoing activity on the Cornwall Tourism social media platforms, all driving traffic to the *CornwallTourism.com* website.

Activity on the website has largely returned to pre-pandemic levels, with the website delivering 100,000 page views during the months of June, July and August, an increase of 24.5% compared to the same time period in 2019.



Cornwall Tourism secured funding under the Canada Summer Jobs program to assist with the hiring of two student tourism ambassadors for the summer months. A pop-up visitor information centre was established at the entrance to the Cornwall Civic Complex and Lamoureux Park and proved to be very popular.

The location of the visitor information centre is advantageous given its close proximity to the waterfront, the Downtown area and the cycling trails, with many visiting cyclists choosing to park and set off from the Civic Complex parking lot. Through a unique partnership with Destination Ontario, a third student from the Ontario Travel Information Centre in Bainsville joined the Cornwall Tourism team to provide additional visitor services support in Cornwall.

#### Conferences, events and sport tourism

In April, Tourism supported the United Empire Loyalists' Association of Canada (UELAC) 2021 conference which was hosted virtually from Cornwall over four days, with 200-plus delegates registering from around the world. Tourism staff continue to lend support to other major sport tourism events including the 2021 World Junior A Challenge in December and numerous professional fishing tournaments in the summer and fall.

#### **Tourism product development**

Staff have been working closely with entrepreneurs to support and assist with new tourism experiences and activities in the city. These experiences have the potential to attract additional visitors to Cornwall and by extension, spin-off visits and purchases at other local businesses and amenities. Some of these new businesses include:

- Waterfront Tours (waterfront pedicab tours)
- The Craft Shack (waterfront craft beer and entertainment)
- Cornwall Food Tours (food tour picnics and in-person food tours)
- Boatingery Adventure Trends (kayak rentals at Guindon Park)
- Escape Bicycle Tours (multi-day bike tours from Ottawa).

Staff have also been working closely with the team at the Native North American Travelling College on Cornwall Island to highlight this unique tourism offering in the area.

The Tourism Development Fund is in place to support new event and tourism product development. The Fund is supported by revenues from the Municipal



Accommodation Tax and is overseen by a separate, stand-alone entity, the Tourism Development Corporation of Cornwall (TDCC).

The TDCC met in June to review two applications for the Tourism Development Fund. To date in 2021 the TDCC has awarded just over \$80,000, \$25,000 of which is for the Cornwall Arts Centre, the second installment of a previously awarded application for \$25,000 a year for four years.

#### **Cornwall Planning Programs Evaluation Group**

Efforts to engage local property owners in improving their properties continue with the administration of community improvement plans, overseen by the Cornwall Planning Programs Evaluation group (CPPEG).

The housing market has been extremely strong through the pandemic with contractors and developers at capacity and significant new housing starts. Even still, the shortage of housing for new workforce needs has encouraged the municipality to develop new programming for hi-density residential in key areas of the city using a tax increment funding strategy through the Heart of the City CIP.

CPPEG continues to review applications within the CIP's Policy Areas under three community improvement plans in place: Heart of the City CIP, Brownfields CIP and Renaissance Housing Rehabilitation Program.

Notable projects include:

- 1 Second St E Prime Square construction has started
- 113 Second St E new location for Ming & Associates and BDO
- 116 Pitt St new restaurant Carrots~N~ Dates, owners relocating from Windsor to open their second location in Cornwall
- 12-16 Second St E the relocation of Eastern Ontario Training Board and the Chamber of Commerce to the newly renovated space took place on June 1<sup>st</sup>.
- 180-182 Ninth St W new location for Menard~Robertson custom home builders
- 24 Ninth St E relocation of Bicycle World
- 30 Sixth St E new location for the Seaway Valley Theatre Company
- 146 Chevrier Centre Charles-Emile Claude continuing with infrastructure renovations to continue help serving the community



The Cornwall Business Enterprise Centre (CBEC) remains busy connecting with area entrepreneurs to discuss business planning, marketing, and financial forecasting.

#### Webinars

CBEC ran 21 different webinars from mid January to the end of June with over 140 businesses participating. Topics included business planning, marketing, use of social media, financial planning, work-life balance, etc. The Centre will be releasing a new schedule of webinars that will take place over the next three months.

#### Summer Company

Summer Company operated with a full complement of seven (7) students participating. Businesses included an ice cream shop, tutoring, flower crowns, lawn maintenance, on-line retail, plant sales and the sale of chicks and eggs.

All seven students were able to operate with COVID-19 distancing regulations and successfully completed the program.

#### **Starter Company PLUS**

The spring cohort of Starter Company PLUS had 29 applicants who worked through the program and produced business plans and financial forecasts. Of the 29 there were 9 applicants approved for a total of \$32,700 in grants. Businesses covered a broad spectrum – bath products, metal art, canvas art and jewellery, footcare, a law office, maple products, microgreens, fitness program and nutrition. CBEC staff continue to work with these entrepreneurs as they continue to build their businesses.

Following an August intake, CBEC staff are just beginning to work with a new cohort of 31 applicants. Grant pitches are scheduled for November 2021.

#### **Exploring Main Street Video Series**

Local "main street" businesses have been featured with short promotional videos that can also be used by each business to augment their website and other marketing efforts. 31 videos were produced as part of the Exploring Main Street video series. The videos have proven to be very popular, garnering over 20,000 views so far – and counting. The videos were produced by two local videographers and fully funded via the *Digital Main Street* program. The videos



are hosted on both the Choose Cornwall and Cornwall Business Enterprise Centre You-tube channels and have been profiled on social media.

#### **Digital Main Street Program**

Over 75 businesses in Cornwall and SDG area are improving their online presence with the help of the Digital Mainstreet program.

#### **Digital Consult Program**

The Digital Consult Program provides one-on-one consultations with local experts in a variety of topic areas, including finance, marketing, legal matters, etc. The program is available to any business that needs advice as they operate through and recover from the COVID-19 pandemic. Participants are able to access a maximum of three consultations. A grant of \$32,000 was obtained to run this program which began in December and will conclude by September 30<sup>th</sup>, 2021.

A total of 54 businesses have taken advantage of Digital Consult Program to date, for a total of 75 consultations.

Information on upcoming webinars and local support programs is regularly updated on BusinessEnterpriseCentre.ca.

#### Purpose

The Purpose and Effect of this By-law is to remove Part Lot Control from certain lots in the Eastridge Subdivision.

That Council approve the following:

a) That Part Lot Control be removed from Lot 6 only of Registered Plan 52M53
 – Eastridge Subdivision; and

b) That Part Lot Control be reinstated on the semi-detached lots in the Eastridge Subdivision, once the subject lots have been created by the appropriate procedure.

#### **Background / Discussion**

It has been the traditional practise of developers to use the consent process, as opposed to the removal of Part Lot Control process in further subdividing semis and townhouses, once the structures are built. However, the surveying to create individual parts for each semi-detached dwelling is essentially the same whether a landowner proceeds with a technical severance or with a Part Lot Control Exemption By-law. It becomes the Surveyor's responsibility to ensure that the dividing line between both dwellings is correctly placed along the centre line of



the demising wall between dwelling units. The overriding advantage of the Part Lot Control exemption bylaw is the efficiency it brings to the process. The reason it was created is the overall realization to simplify processes once and only once all the Planning issues have been dealt with. Such is the case with this Subdivision, where the public was notified twice through the Zoning and Subdivision processes. The municipality has exercised its' responsibilities in arriving at a Subdivision Agreement to ensure that all adjacent interests have been addressed.



# Purpose

The Purpose and Effect of this By-law is to remove Part Lot Control from certain lots in the Eastridge Subdivision.

That Council approve the following:

a) That Part Lot Control be removed from Lot 6 only of Registered Plan 52M53
 – Eastridge Subdivision; and

b) That Part Lot Control be reinstated on the semi-detached lots in the Eastridge Subdivision, once the subject lots have been created by the appropriate procedure.

## **Background / Discussion**

It has been the traditional practise of developers to use the consent process, as opposed to the removal of Part Lot Control process in further subdividing semis and townhouses, once the structures are built. However, the surveying to create individual parts for each semi-detached dwelling is essentially the same whether a landowner proceeds with a technical severance or with a Part Lot Control Exemption By-law. It becomes the Surveyor's responsibility to ensure that the dividing line between both dwellings is correctly placed along the centre line of



the demising wall between dwelling units. The overriding advantage of the Part Lot Control exemption bylaw is the efficiency it brings to the process. The reason it was created is the overall realization to simplify processes once and only once all the Planning issues have been dealt with. Such is the case with this Subdivision, where the public was notified twice through the Zoning and Subdivision processes. The municipality has exercised its' responsibilities in arriving at a Subdivision Agreement to ensure that all adjacent interests have been addressed.





Whereas section 345 of the Municipal Act, 2001 authorizes the City of Cornwall to impose late payment charges for the non-payment of taxes or any instalment by the due date; and

Whereas a percentage charge, not to exceed 1 1/4 per cent of the amount of taxes due and unpaid, may be imposed as a penalty for late payment of taxes on the first day of default; and

Whereas interest charges, not to exceed 1 1/4 per cent each month, may be imposed for the non-payment of taxes levied on the amount of taxes in any year which are due and unpaid; and

Whereas the percentage charge and the interest charges are deemed to be part of the taxes on which the charges have been imposed; and

Whereas section 347 of the Municipal Act, 2001 outlines the allocations of payments for taxes;

Now, therefore, be it resolved that the Council of The Corporation of the City of Cornwall enacts as follows:



# **Penalty Charge**

1. A penalty charge of 1 1/4 per cent of the amount of taxes due and unpaid is imposed as a penalty for the non-payment of taxes on the first day of default.

### **Interest Charge**

 Interest charges calculated at the rate of 1 1/4 percent per month of the amount of taxes due and unpaid are imposed for the non-payment of taxes on the first day of each calendar month after the first day of default until the taxes are paid.

### **Deemed Taxes**

- 3. The penalty and interest charges imposed under sections 1 and 2 are deemed to be a part of the taxes on which the charges have been imposed.
- 4. No interest will be charged on penalty and interest charges imposed that are deemed to be taxes under section 3.

### Part Payment

- 5. Part payments of taxes will be accepted and will be credited:
  - a. first, to the oldest penalty and interest charges until all outstanding penalty and interest have been paid;
  - b. secondly, to the oldest taxes (including fees, charges or other amounts that are collected as municipal taxes) until all outstanding taxes have been paid.

# Purpose

Repeal By-Law 2019-077 and replace with revised By-Law 2021-104.

## **Background / Discussion**

By-law 2019-77, item #5, part B requires updating and part C requires removal as it relates to applying partial payments to property tax accounts.

This change is required due to the accounting system configuration of the application of partial property tax payments.

These changes are in accordance with section 347 of the Municipal Act, 2001:

347 (1) Allocation of payment Subject to subsections (2) and (3), where any payment is received on account of taxes, the following apply:

1. The payment shall first be applied against late payment charges owing in respect of those taxes according to the length of time the charges have been owing, with the charges imposed earlier being discharged before charges imposed later.



 The payment shall then be applied against the taxes owing according to the length of time they have been owing, with the taxes imposed earlier being discharged before taxes imposed later. 2001, c. 25, s. 347 (1); 2002, c. 17, Sched. A, s. 60.

# 347 (2) Part payment

Subject to the approval of the treasurer, a part payment on account of taxes may be applied in a manner different than that set out in subsection (1) at the request of the person making the payment. 2001, c. 25, s. 347 (2).

1. (a) That the following Minutes of the Public Meetings of the Municipal Council of The Corporation of the City of Cornwall be and the same are hereby adopted:

(i) Regular Public Meeting of Council #2021-25 of Monday, August 9, 2021

(b) That the following Minutes of the In Camera Meeting pertaining to the security or part of the property of the Municipality or Local Board, personal matters about an identifiable individual, including municipal or Local Board employees, a proposed or pending acquisition or disposition of land by the Municipality or Local Board, labour relations or employee negotiations, litigation or potential litigation, including matters before administrative tribunals, affecting the Municipality or Local Board, advice that is subject to solicitor-client privilege, including communications necessary for the purpose, a matter in respect of which a Council, Board, Committee other body may hold a closed meeting under another Act, or for the purpose of educating or training the members and where no member discusses or otherwise deals with any matter in a way that materially advances the business or decision-making of the council, local board or committee, be and the same are hereby adopted:

3. The Mayor and proper officials of The Corporation of the City of Cornwall are hereby authorized and directed to do all things necessary to give effect to the above-mentioned actions and to obtain approvals where required.

4. Unless otherwise provided, the Mayor and Clerk are hereby authorized and directed to execute and the Clerk to affix the seal of The Corporation of the City of Cornwall to all documents necessary to give effect to the above mentioned actions.

5. It is declared that notwithstanding that any section or sections of this Bylaw or parts thereof, may be found by any court of law to be bad or illegal or beyond the power of the Council to enact, such section(s) or part(s) hereof shall be deemed to be severable and that all other sections or parts of this By-law are separate and independent there from and enacts as such.
